With more than 20 years of experience in the field of ADR, the author captures this beautiful sunrise, critically discussing how the same can be focused towards the enhancement of Access to Justice in Kenya.

Drawing from his earlier works, the author objectively evaluates the principles of conflict management, taking the reader through each mechanism while linking it to Access to Justice. The author navigates through Traditional Dispute Resolution, challenges to its full utilization, as well as its relationship to ADR. He then comprehensively travails the Kenyan legal and policy framework in relation to ADR, critically analysing its cogency in achieving the object of complete access to justice.
